Important Note Regarding Fee

- The applicant's admission to IILM Academy of Higher Learning, Lucknow will be confirmed only on receipt of the Registration Fee on or before the Last Date mentioned in the Provisional Admission Offer Letter.
- In case of delay in the deposit of the Registration Fee or non-submission of required Documents, the Admission Committee solely reserves the right to continue/postpone/withdraw/cancel the Provisional Admission Offer made to the applicant.
- In case of any discrepancy and/or false information provided by the applicant, the Admission Committee solely reserves the right to cancel the Provisional Enrollment of the applicant.
- Indulgence in any illegal or unethical action violating the code of conduct of the Institute will subject the applicant/student to disciplinary action and/or expulsion from the enrolled program as per IILM Policy.
- Refund of Fees will be as per AICTE Refund Policy.

Important Note Regarding Scholarships

- The Applicant must meet the minimum academic eligibility criteria of the PGDM / PGDM (FM) program and should get selected through the Institute's Selection Process.
- Scholarships are granted on an annual basis and the continuation of the on-admission Scholarship in the second year of the program is subject to the Scholarship Continuation Policy.
- Scholarships will be confirmed to the selected students based on the decision of the Scholarship Committee and after verification of original documents.
- Grant of Scholarship is subject to the approval of the Scholarship Committee.
- In all categories of Scholarship, limited scholarship seats are available and the same will be granted on first come first serve basis.
- The last date to apply for on-admission scholarships for the first year is July 31, 2024.
- The scholarship will be given after joining the program and the excess fee (if any) paid by the student will be adjusted in the next fee installment.
- The applicants must support their scholarship applications with documentary evidence justifying the scholarship.
- Scholarships are granted on an annual basis on Tuition Fee component only and continuation in the second year of the program is subject to the Scholarship Policy.
- Student cannot avail of any combination of Scholarships and/or Concessions. Only one type of Scholarship/Concession (whichever is higher) can be availed.
- In the absence of complete detail in the prescribed format and relevant Sports / Martyr Certificates &/or other Relevant Supporting Documents, the Scholarship Application will not be considered and will stand canceled.
- In the case of Sports Scholarships, the Applicant's Age should not be more than 23 years, as of July 31, 2024.

Important Note Regarding Continuation of On-Admission Scholarships in the Second Year

- All Scholarships are granted on an annual basis on the Tuition Fee component only and the continuation of the on-admission Scholarship in the second year of the program is subject to the Scholarship Continuance Policy, as below.
- All students on scholarship must maintain more than 80% attendance in every trimester and should not have been debarred due to any reason.
- To continue availing of 100% scholarship, students must secure a position in the top 10% of the merit list for the program and obtain a minimum CGPA of 9 and above in the First year, with no backlogs.
- To continue availing 40% scholarship, students must secure a position in the top 15% of the merit list for the program and obtain a minimum CGPA of 8.5 and above in the First year, with no backlogs.
- To continue availing 20% Scholarship, the student must secure a position in the top 20% of the merit list for the program and obtain a minimum CGPA of 8 and above in the First year, with no backlogs.
- To continue availing 10% Scholarship, the student must secure a position in the top 30% of the merit list for the program and obtain a minimum CGPA of 7.5 and above in the First year, with no backlogs.
